Our Commitment

Our Policy

HCS protects the privacy of our clients and website visitors. We will collect, use and store your personal data in a secure way. We promise to use your personal information for only the specific purpose stated and to keep you informed on how we use your information and who we give it to.

User Consent

Cookie Policy

Cookies are small, usually randomly encoded, text files that help you navigate through a website. We work with carefully selected third parties for website tracking and analytics. We use Google Analytics which tracks website page visitor's activity and other anonymous information. You may opt-out of Google Analytics tracking on all websites that use it by installing the Google Analytics opt-out add-on to your browser.

In addition to Google Analytics, we use a third party marketing software to track website visitor activity. The information tracked may include your IP (internet protocol) address, your web browser, the time you visited the site, webpages visited and other data.

Personal Information

HCS collects information visitors knowingly and voluntarily provide when using our site. Examples of such information include data provided when completing a website form, signing up for our mailing list, subscribing to our blog, completing surveys, or sending e-mails with questions or feedback. HCS uses this personal information only for the purpose for which the user provided it.

Security of Personal Information

HCS provides safeguards to protect confidentiality, security and integrity of personal information. Although security measures are taken to help protect all personal information against



unauthorized disclosure, misuse or alteration, HCS cannot guarantee the security of information provided over the internet and will not be responsible for breaches of security beyond our reasonable control.
